About Ethex

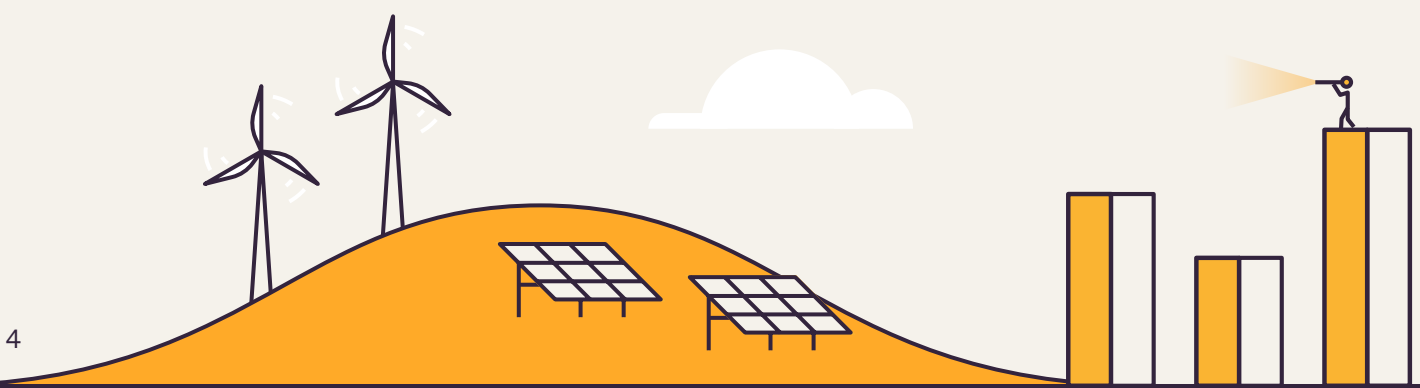

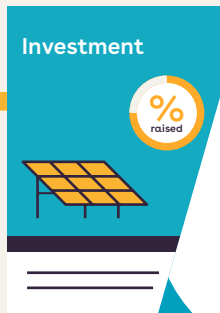

Tax benefits that work for you

Doing good with your money doesn't just feel good, but can be tax efficient too.

Some of the investments listed on Ethex not only support positive change for people and the planet while targeting a fair financial return, they also come with valuable tax benefits. From Innovative Finance ISAs (IFISAs) to Community Investment Tax Relief (CITR) and potential Inheritance Tax (IHT) relief, some opportunities on our platform could help your money work even harder, in more ways than one.

IFISA

Innovative Finance ISA

Get returns paid free of UK income tax using your annual ISA allowance. Invest in eligible offers using your tax-free allowance or transfer in previous ISA balances, so they can start making a positive impact. You can use your annual £20,000 ISA allowance or transfer in any existing ISA balances you have.

IHT

Inheritance Tax Relief

Investments in qualifying unlisted shares may be eligible for Business Relief, potentially reducing the IHT liability on your estate after 2 years.

CITR

Community Investment Tax Relief

Investing in accredited Community Development Finance Institutions (CDFIs) can attract CITR of up to 25% of investment over 5 years. Available on selected qualifying offers.

Community energy



Solar, wind and hydro projects owned by and for the benefit of local communities. Invest in the clean energy transition while earning competitive returns.

Food & land



Regenerative farming, rewilding and community food projects. Support a sustainable food system that works for people and the planet.

Affordable housing



Community land trusts and housing co-ops building sustainable homes that are permanently affordable. Your investment helps people stay in the communities they love and tackle the UK housing crisis.

Affordable finance



Credit unions, CDFIs and ethical lenders providing fair access to finance for those underserved by mainstream banking, helping them avoid debt and attain financial wellbeing.

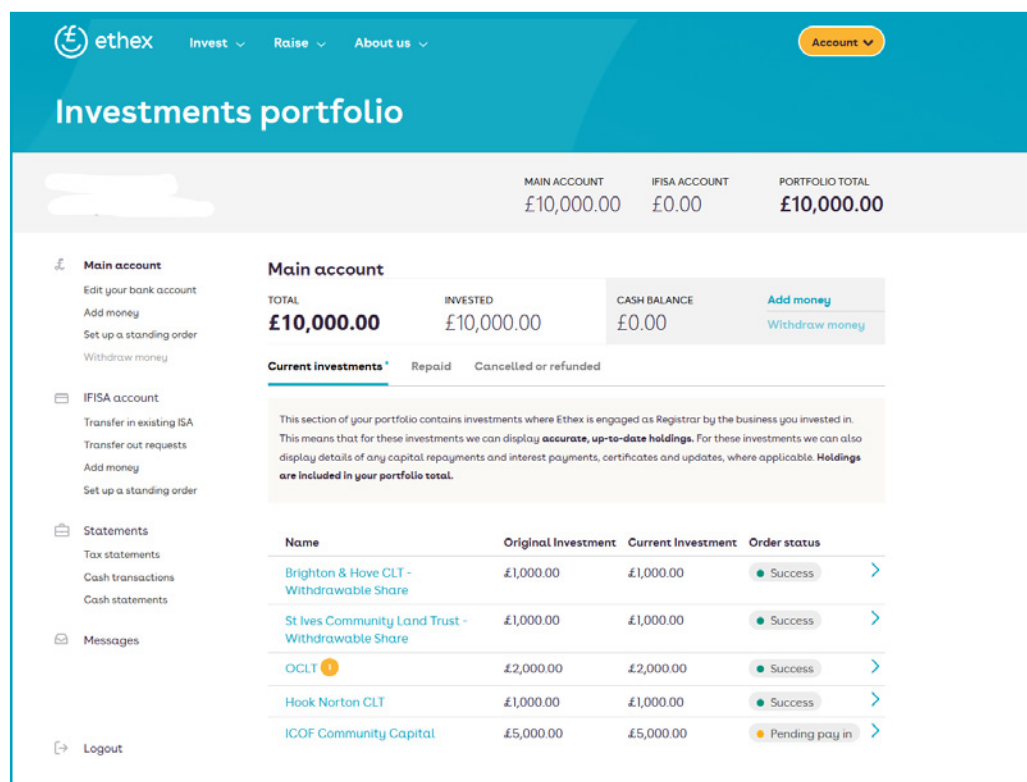
